HKIA Industry Partnership Scheme – Application Guidelines

A. Eligibility

1. Suppliers, contractors, service providers or the like of a business in connection with the architectural profession are considered eligible to apply for this Scheme.

B. Benefits

1. Opportunities to conduct Continuing Professional Development (CPD) programme to HKIA Members to share the business of the Industry Partner once every year free of charge.
2. Opportunities to sponsor HKIA activities and programme(s).
3. A maximum of TWO (2) advertisement e-banners can be displayed on the HKIA website in accordance with our display specifications and requirements.

C. Submission of Application

1. Fill in all sections of our specified Application Form where appropriate including the accurate and true statement of the company and the related personal particulars.
2. Certified True Copies of the following company documents shall be attached with the application:
 - Certificate of Incorporation to show the place of registration [including the applicant and its parent company (if applicable)],
 - Business Registration Certificate to show the registration validity [including the applicant and its parent company (if applicable)] and
 - Annual Return & Directorship Information.
3. The applicant shall prove that the Nature of Business is in connection with the architectural profession. HKIA reserves the right to review from time to time the business nature and may request further document(s) for justification.
4. The copies of documents attached for application shall be certified and duly signed by the Director provided in Section B1.
5. All applications will be vetted and endorsed by the HKIA Council.
6. HKIA reserves the right to review the admission rules without prior notice to the applicant.



D. Subscription Period

The subscription period is as follows:

E. Partnership Fee

- Partnership fee will be charged to the Applicant for joining this Scheme at the rate specified by HKIA and to be displayed on the HKIA website. The fee will be charged on an annual basis, with a three-year option.

- Successful applicants will be notified on the detailed payment methods upon the endorsement of the HKIA Council.

F. Personal Data

- The data provided in for application will be used for the purposes of the application only.
- If an application is successful, the corporation and personal data will be retained and used by HKIA for the purposes of administration of the Industry Partnership Scheme only.
- Names and qualifications of applicants may be placed in HKIA publications.
- Applicants are requested to notify HKIA of any changes in their data, including but not limited to any change of Directorship within a month.
- Under the terms of the Personal data (Privacy) Ordinance, an applicant has the right to request access to and correction of any data relating to that applicant, but a fee as permitted by the Ordinance may be charged by HKIA for dealing with any such request.



G. Intellectual Property

The Institute of Architects takes the protection of its intellectual property very seriously.
