## Deed of Constitution

WE, THE UNDERSIGNED being met together on the third day of September in the year one thousand nine hundred and fifty-six and being desirous of forming a Society in the Colony of Hong Kong for the general advancement of Civil Architecture and for promoting and facilitating the acquirement of the knowledge of the various Arts and Sciences connected therewith DO HEREBY BAND OURSELVES TOGETHER IN A SOCIETY TO BE KNOWN AS THE HONG KONG SOCIETY OF ARCHITECTS and do undertake as Foundation Members to subscribe to the funds and be bound by the Rules of the Society AND DO FURTHER DECLARE AND AGREE AS FOLLOWS:

- 1. that the Society shall consist of Members, Honorary Members, Associates, Graduates and Students;
- 2. that the Society shall elect and be governed by a Council consisting of a President, two Vice-Presidents, and such other Officers and Members of Council as it may decide;
- 3. that the Society shall make such Rules for its own good governance and the conduct of its members as it may from time to time think fit;
- 4. that the Society shall have power in its corporate name to acquire, hold and dispose of property and funds and shall to this end comply with Ordinances of the Government of Hong Kong;
- 5. that the Society shall invite and have as its Patron a person of eminence in colony.

#### **Formation**

On 3rd September, 1956, 27 architects gathered and formed a Society "for the general advancement of Civil Architecture and for promoting and facilitating the acquirement of the knowledge of the various Arts and Sciences." Thus The Hong Kong Society of Architects was formed. On 7th May, 1957, the first amendments were made, to stand for over two and a half years. During this period the membership of the Society increased by 50% and recognition as an Allied Society was given by Royal Institute of British Architects. In accord with this growth further amendments were made to come into effect on 3rd November, 1959. By the end of 1962, the Society expanded to a membership seven times as large as that first body of foundation members.

The changes of name from Society to Institute was effected in 1972 after a great deal of preparatory work, and has initiated a new phase of activity in the Institute's affairs. Members will use the professional affix - Architect HKIA and describe themselves as Member of The Hong Kong Institute of Architects. Associates will describe themselves as Associate of The Hong Kong Institute of Architects in full. No abbreviation of this is permitted.

#### **Purpose**

The two main purposes of the Institute are to continue to raise both the standard of architecture in Hong Kong and the standard of professional services offered by its members.

#### **Code of Professional Conduct**

In addition to the responsibilities of architects as professionals under law, members of the Institute are governed by a Code of Professional Conduct. This Code aims to provide the standard of professional conduct and self-discipline required of the members of the Institute in the interest of the general public.

#### Discipline

A member whose conduct is found to be in contravention of the Code or dishonouring the principle of the Code is liable to reprimand, suspension or expulsion. This ensures that the public receives from HKIA members only the highest standard of professional service.

#### Service to the Public

The Institute also serves the public by applying the collective expertise of its members in an advisory role to government and to the building industry. Today, HKIA is represented in numerous consultative or advisory bodies ranging from a working group which counsels the drafting of new building and planning legislation to a committee which formulates standard contracts for use in the building industry.

#### Architectural Education .

In the field of education, the Institute works closely with the two Universities, namely, the University of Hong Kong and the Chinese University of Hong Kong and offers courses and counsel in professional practice and practical experience in architecture.

#### **Professional Qualification**

Every year, candidates aspiring to the professional qualification of Architect sit a professional examination held by the Institute. Successful candidates receive recognition not only from professional bodies in Hong Kong but also in UK, Australia, Canada, USA and other countries.

#### **International Participation**

In recent years, the Institute takes Hong Kong to the fore in international circles through its active participation in the International Union of Architects (UIA), the Commonwealth Association of Architects (CAA), and the Architects Regional Council of Asia (ARCASIA).

#### Organization

Today, The Hong Kong Institute of Architects has more than 1500 full members and over 300 associate members and graduate members. The Institute is governed by a Council formed by a President, two Vice-Presidents, an Honorary Secretary, an Honorary Treasurer and 14 Council members. The Council appoints 5 Boards, each charged by a member of the Council, to deal with specific areas in the objectives of the Institute. They are the Board of Internal Affairs, the Board of External Affairs, the Board of Educational Affairs, the Board of Local Affairs and the Board of Practices. These Boards in turn appoint committees to deal with matters within the area of responsibility of the Boards.

## **Report from The President**

In addition to a number of articles in our Journal on concerns of the profession and my reports to you every month about our activities, I wish to summarize some of the more important works of the Institute this year.:-

#### Promotion in architectural design

The Institute has sponsored successfully a number of architectural competitions including the Annual Awards, the Young Architect's Award and the Shui Chuen O Housing Project. Personally, I have served in the jury panel of the Annual Awards, the Building Manager of the Year and 'Learn to Care' at the World Day of Architecture; and will be serving as jury member also in the West Kowloon Reclamation Concept Plan, the School Design and other competitions. HKIA and HKIP have also jointly organized urban design seminars and will be working closely together with an aim to improve our urban environment. We have also submitted the Tai O Redevelopment Plan to the Planning and Lands Bureau for consideration and implementation.

The Chief Executive has concurred with our view not to adopt standard design for public housing and schools in his policy address this year. This will be a huge impact to our environment and allow more design opportunities for both public and private architects. The Government has also informed us that private architects will have more opportunity to design public buildings as well in the near future.

#### Promotion of quality professional services

The Institute has worked closely with the Education Department in order to allow smaller practices to be able to become architects for the SIP programme with a view to offer quality professional services to improve the much needed facilities for learning. In another area, through the efforts in working hand in hand with other professional institutions, we are forming the Professional Green Building Council to work on sustainable building standards for this region. The Coalition of Professional Services has also been formed in order to promote quality professional services internationally and to China. In this respect, the Government has responded positively by setting up a billion dollar fund to assist projects of the members of the Coalition. Concerns have been raised to Government regarding the approved list of consultants and the two-envelope system of selection. All signs have now indicated that these matters are being reviewed, and my knowledge has confirmed that Government is moving towards a true partnership with us for quality professional services to our community.

#### **Boards and Committees**

With the creation of the Board of Practices, the Institute has now five Boards and thirty-four Committees. This year with the creation of the new website, our communication is much improved. I am indebted to the Council, the Board & Committee members with the assistance of the Secretariat for all your active participation. This has brought about a number of positive improvements in all internal and external programmes. In particular, we have actively responded to the goals of the construction industry reform. We have now tested our disciplinary mechanism in order to instill a greater sense of accountability in our integrity as professionals. We have conducted a survey asking members to respond with regards to our CEPD programme. The Board of Educational Affairs together with Architects Registration Board have also been active to work





out the revised professional assessment requirements for local and non-local professionals. This will tie in with our negotiation with the Registration Authority in China for reciprocal recognition of our professional examinations. Our Membership Committee is considering the conditions of affiliated membership for site supervisors and technicians. Council members & myself have also made a number of trips to foster China and international relationships. In this respect, I wish to invite you to consider attending the UIA Berlin 2002 'Resource Architecture' conference in July and the New Dehli ARCASIA Forum in September next year.

#### **Future Plans**

Council members have recently met to discuss our future directions. In addition to focus more activities for young members, the Council wishes to develop the concept of a Centre of Architecture for Hong Kong. With the assistance of the Government we hope to be able to conserve a suitable historical building for this purpose.

#### 1ST QUARTERLY GENERAL MEETING Hon Secretary Report, on 1 April 2001

#### I HKIA Examination 2000

#### Paper 4 Professional Interview

The Professional Interview was held on 30 March 2001. The rigorous full-day exercise was made possible by the concerted efforts of 36 senior HKIA Members and Fellows, forming 12 interviewing panels to examine 126 candidates. The passing rate for Professional Interview is 71.4%

#### **Passing Rates**

The conclusion of the 2000 Examination saw the offer of admission to 85 new HKIA Members, representing an overall passing rate of 33.5% (HKIA) 35.4% (ARB). Detailed passing rates of individual examination papers are shown in Table 1 below:

#### II Education & Careers Expo 2001

The event enabled the Institute to reach out to students, parents and the general public on architectural education and the architectural profession.

#### III CEPD Activities

In the period under review, the CEPD Committee organized the Seminar on "Fire Safety Engineering Approach - Special Design beyond Prescriptive Fire Codes", which was attended by over 200 Members. The Seminar was well-received by the audience.

Forthcoming CEPD activities include an Urban Design Seminar Series in May jointly organized with the HKIP. A mediation course for architects and other interesting events are being planned for, and details will be announced by circular in due course.

#### IV Awards & Prizes

#### HKIA Annual Awards 2000

32 entries for Silver Medal / Certificate of Merit, 15 entries for President's Prize and 20 entries for Award for Members' Work Outside of Hong Kong were received this year.

The jury exercise was completed and announcement of results shall be held on 1 April 2001 at a press conference to be held at the HKIA Premises.

The Exhibition of all the entries shall be held at Park Court, Pacific Place from 2 to 5 April 2001. The Prize Presentation Ceremony of both Annual Awards and Young Architects' Award shall be held on 2 April 2001 at the same venue.

#### Hong Kong Real Estate Services Expo & Conference, Beijing

The Institute was one of the supporting organisations to the captioned Expo, organised by the Hong Kong Trade Development Council and held in Beijing from March 15 to 17, 2001. Information on the Institute was displayed in the exhibition and included in the Expo catalogue and also the official website.

#### VII Presentation / Forum / Gathering

a. Joint Seminar on Review of Lighting & Ventilation Requirements in Buildings, 21 February 2001 14 members attended the captioned Seminar with other representatives from allied professional institutes on 21 February 2001 at the Joint Professional Centre. During which, Anthony Ng, delivered a power joint presentation on Consultancy Study on Review of Lighting and Ventilation Requirements in Buildings.



UIA/ARCASIA Seminar "Design For All - An Inclusive Approach" 7 September 2001



#### **CEPD Questionnaire**


To gauge Members' opinion on improvements to the current CEPD programme and CEPD events, the CEPD Committee issued a questionnaire to general members in end-November.





#### NOTES TO THE FINANCIAL STATEMENTS

#### Activities and operations

The Institute is registered under the Hong Kong Institute of Architects Incorporation Ordinance for the general advancement of Civil Architecture and for promoting and facilitating the acquisition of the knowledge of the various Arts and Sciences connected therewith. Principal activities include the holding of meetings, lectures, examinations, exhibitions, competitions and similar activities.

### 2. Summary of significant accounting policies

#### (a) Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with Statement of Standard Accounting Practice issued by the Hong Kong Society of Accountants and generally accepted accounting principles in Hong Kong.

#### (b) Principles of consolidation

The consolidated financial statements for the year ended 30 September 2001 include the accounts of the Institute and its wholly-owned subsidiaries, HKIA Services Limited and Star Creation Development Limited. Both companies are incorporated in Hong Kong.

HKIA Services Limited owns the land and building acquired during 1985 (Note 6) which is occupied by the Institute up to 31 July 1997 and thereafter was re-classified to investment property on 1 August 1997.

Star Creation Development Limited was incorporated and commenced business on 20 March 2000. It is intended to be engaged in general trading.

Intercompany balances and transactions have been eliminated on consolidation.

#### (c) Intangible asset

The intangible asset represents the expenditure incurred for and capitalised for development and production of a web site. The costs were capitalised and are being amortized from 1 September 2001, when the asset was available, for use for twenty years.

#### (d) Leases

#### (i) Operating leases

Leases where substantially all the risks and rewards of ownership of assets remain with the lessor are accounted for as operating leases. Rentals under operating leases are charged to the profit and loss account on a straight line basis over the lease term.

#### (ii) Finance leases

Leases where substantially all the risks and rewards of ownership of assets are transferred to the lessees are accounted for as finance leases. The amount recorded as an asset and obligation under finance least at the inception is the present value of minimum lease payments payable during the term of the lease. Rentals payable in respect of finance leases are apportioned between finance charges and reduction of outstanding lease obligations based upon the interest rates implicit in the relevant leases.

#### (e) Depreciation

Depreciation is calculated to write off the cost or valuation of property, furniture and equipment over their useful lives on the straight-line basis, at the following annual rates:-

Investment property NIL Furniture and equipment 25% Office computer 25% Leasehold improvements 20%



#### (f) Inventory

Inventory consists mainly of standard contract forms, Standard Form of Building Contract, Form of Tender which are stated at the lower of cost or net realisable value. Cost includes direct costs of purchases and incidental costs in bringing the inventory to their present location and condition. Net realisable value is based on anticipated selling price less all further costs to be incurred prior to sale.

#### (g) Taxation

The Institute has been granted exemption from Hong Kong Profits Tax by the Inland Revenue Department for its prior years, excess of income over expenditure. The Council believes that similar exemptions will continue to be granted accordingly no provision for Profits Tax has been made.

The Institute's subsidiary, HKIA Services Limited, has provided for Hong Kong profits tax at the rate of 16% on the estimated assessable profit for the year.

No provision has been made for the Institute's other subsidiary, Star Creation Development Limited, as it has not commenced business during the year.

#### (h) Investment property

Investment property represents leasehold land and building held in Hong Kong under a long term lease. The company has adopted the recommendations of Statement of Standard Accounting Practice No 13 issued by the Hong Kong Society of Accountants whereby investment properties are not depreciated.

#### (i) Related party

A party is considered to be related if one party has the ability, directly or indirectly, to control the other party or exercise significant influence over the other party in making financial and operating decisions. Party is also considered to be related if it is subject to common control or common significant influence.

#### 3. Revenue recognition

#### (a) Members' entrance and subscription fees

Members' entrance and subscription fees are credited to income in the year of receipt. Annual subscription fees are taken up on an accrual basis.

#### (b) Lecture and examination fees

Lecture and examination fees are recognised when the lecture and the examination are held.

#### (c) Publications and advertisements

Revenue from sales of publications and advertisement is recognised when the publications are sold and the advertisements are published.

#### (d) Exhibitions and other functions

Revenue from exhibitions and other functions are recognised when the functions are held.

#### 4. Prior year adjustment

This represents adjustment for incorrect cut off of examination resitting fee amounting to HK\$550,500 related to the year ended 30 September 2000.


#### (a) Basis of accounting
